## WHAT ARE THE CARE AND ACCOMMODATION COSTS?

There are a number of costs associated when entering Residential Aged Care.

At Nazareth Care you can be expected to pay:

**Basic Daily Fee**

Current Fee **\$61.96** per day. An amount everyone pays for day to day services received at the aged care home.

+

**Accommodation Costs**

A varying cost for your room you may be asked to pay, based on your means assessment.

+

**Means Tested Care Fee**

A varying daily additional cost you may be asked to pay for care services received, based on your means assessment.

+

**Additional Services**

We can provide you with detailed information regarding individual or packaged additional services Nazareth Care may offer. This arrangement and their associated costs will be discussed and implemented as a condition of living in our home.

Once your accommodation costs have been determined by your means assessment, resulting in an accommodation payment / contribution, the following payment options are available to you.

- **A lump sum** - Refundable Accommodation Deposit/Contribution (RAD/RAC)
- **Rental style daily payments** - Daily Accommodation Payment/Contribution (DAP/DAC)
- **A combination of both** - This is when you combine the two types of payments to meet your costs. You can split the combination any way you choose.

### WHAT ARE MY REGULAR PAYMENT ARRANGEMENTS?

At Nazareth Care our payment method is a monthly **Direct Debit** from your nominated account. This full month payment occurs on the **15th of each month or next business day.**

### FURTHER SUPPORT AND CONTACTS

Working out how much you will pay for Aged Care is key when deciding what aged care provider is right for you. Services Australia evaluates your means (Assets and Income) and determines the cost of your care. By contacting Services Australia you can begin to understand and identify what information, forms and supportive documents are required to establish the cost of your care. At this time, you may also wish to consider appointing a Nominee for additional support when interacting with My Aged Care and Services Australia.
